My dear Andrew,

I send with this a copy of to day's "Argus", on p. 3 of which you will notice the advt of my partnership. Will you kindly have the substance embodied ^{as a local} in the "Mercury", & doubtless a note from you to George Edwards (to whom my fraternal regards go with this) would ensure a similar notice in one of the Launceston dailies.

I hope soon to receive from you my Commission for taking affidavits. I will then send P.O. Order for £2.2.0, less on same to Mr Pearce's, which latter I duly rec'd from your firm but owing to negligence of work omitted to acknowledge.

2/ I should tell you that I have just finished the trial of the heaviest case (save one) I have had in this Colony. This was an Action of Webster v White & was one of disputed Apts between two Merchants - one in Sydney & the other of Melbourne - & involved going into all their transactions, Apts & correspondence for the last 7 years (It became necessary for me to go thro' some thousands of letters). I worked at it incessantly for about 3 weeks - night & day, and, for the last 8 days preceding the trial, on an average 16 hours a day. It was tried before Judge Cope (!) & a special jury of 12. The trial lasted 5 days & the findings of the jury are of such an

inconsistent nature that both parties are making to later judgment & we have also appealed. The Briefs & copies of Exhibits form a mass of papers standing about a foot high - It will keep me going for many a day to come & also throws me back very much in my ordinary work - Hence, the fragmentary nature of my latest epistles.

So much for "shop."

Well, how do you like the "Gap"? I am anxiously, even nervously, looking out for your opinion - Anyhow, I hope for the poor author's sake, that you will do what you can to help the sale - Withon thanks highly
