# Royal Society of Tasmania

Annual Report for the Year ended 31st December, 1959.

The Society was honoured when His Excellency the Governor of Tasmania, the Right Honourable the Lord Rowallan, signified his willingness to accept the office of President of the Society. In passing it is interesting to note that since 1843, when the Society was formed by the then Lieutenant-Governor of the State, the office of President has been filled by successive Governors.

The year under review can be considered satisfactory from the Society's point of view. The membership total reached 558, of whom 204 were listed on the Northern Branch centred at Launceston.

After the presentation Sir Edmund addressed the Society, his subject being "Crossing Antarctica ".
