Annual Report for the Year 1969

The Council submits to members the following report on the activities of the Society for the year 1969.

PRESIDENT

As mentioned in the last Annual Report, His Excellency the Governor, Sir Edric Bastyan was approached and asked to accept the office of President of the Society. It was with great pleasure that the members learned of Sir Edric's willingness to become President and so follow in the footsteps of all the Governors of the State since 1843.

THE SOCIETY AND ITS HEADQUARTERS

At the Annual Meeting held in March the question of the location of the Society and its library was considered by members. The Council of the Society had recommended that the offer of the University Council to provide appropriate accommodation in the library extensions at the University should be accepted under conditions drawn up and approved by the Honorary Solicitors of the Society. Members entered into a wide and useful discussion on the whole matter and finally agreed to adopt the Council's recommendation as far as housing the library was concerned, but on the express understanding that the Society will remain as an autonomous body. The matter of a meeting place was discussed further and points of view were put forward by members, some being in favour of retaining the present room for meetings, others feeling that the offer of the University to provide lecture rooms should be accepted, while yet others felt they would like the matter considered further. The Council was asked to review the whole matter of meeting places and report to the members at the Annual Meeting in 1970. It is expected the library move will be made about the middle of 1970.

ELECTION

Elections were held for the vacant positions of Vice-President and members of Council. Dr E. R. Guiler was elected a Vice-President and Mr R. M. H. Garvie and Mr L. E. Wall were elected to the Council. Later in the year Mr A. R. Nielson was appointed to a casual vacancy in the Council.

DR W. W. WILSON

The Society suffered a grievous loss late in the year through the death of the Senior Vice-President. Dr W. W. Wilson, who had been a member of the Society for many years. Dr Wilson had contributed to the Papers and Proceedings and had given lectures to the Society and was a member of Council for a number of years.

PAPERS AND PROCEEDINGS

Volume 103 of the Papers and Proceedings was printed and distributed and once again a large number of volumes were sent to research institutions overseas from which we receive, by exchange, so many of the scientific and historical journals which have helped to make our library such a valuable one in certain respects. Five hundred and seventy volumes (books and periodicals) were added to the library during the year.

LECTURES

Another interesting series of lectures was given during the year covering a wide range of topics. The Society is grateful to those specialists who made such a significant contribution to the Society through the lectures and discussions.

November: Professor R. M. Mitchell, Department of Surgery, University of Tasmania, on 'Transplantation of Tissues and Organs'.

MEMBERSHIP

The total membership at the end of the year was 569. Of this number, four are Honorary Life Members and 231 are members of the Northern Branch.

NORTHERN BRANCH

The Branch again functioned with decided success and their general meetings and excursions proved popular and interesting.

Fellows

In the earlier years of the Society's history both Fellows and Members formed the membership. At a later date the term 'Fellow' was dropped since when all in the Society had been listed as 'Members'. This matter was raised at the last Annual Meeting and it was agreed that consideration should be given to re-introducing 'Fellows' of the Society.
